

## Pal College of Technology & Management Scholarship Policy 2025-2026

### **Objectives of The Scholarship Policy**

- To promote academic excellence, support students from disadvantaged backgrounds, and encourage specific fields of study.
- To facilitate students' access to various scholarships.
- Scrutinize the documents for the various scholarship schemes.
- Receive and verify the scholarship applications and recommend them forward.

### **Scholarship Policy Guidelines**

PCTM has established a comprehensive scholarship policy that outlines the rules and guidelines to be followed since the inception of the college. The policy encompasses the awarding of scholarships based on both merit and the government's reservation policy applied to enrolled students. Each academic year, the college aims to grant a scholarship to a deserving student in each discipline.

Additionally, the college recognizes the possibility of providing other forms of financial support, subject to the availability of sponsored funds and compliance with governmental guidelines. The selection process involves meritorious students submitting applications, and special consideration is given to deserving students with exceptional skills in areas such as sports, arts, differently-abled individuals,

culturally-oriented talents, and other specific skill sets. The scholarship committee, established by the college, is responsible for reviewing applications and recommending eligible candidates for the scholarship and any applicable financial support. Ultimately, the Principal holds the final authority to approve the scholarship awards if there is any dispute.

### **Two types of college scholarships are “Category A” and “Category B”**

### **“Category A”**

#### **A (1) Merit Scholarship**

- Awarded to students based on outstanding academic performance in grade 12<sup>th</sup>  $\geq$  70% to 80%  
The value for scholarship will Rs. 2500
- Awarded for II and III years in case the student will be able to secure 12<sup>th</sup>  $\geq$  81% to 90%  
The value for scholarship will Rs. 5000
- Awarded to students based on outstanding academic performance in grade 12<sup>th</sup>  $\geq$  91%  
The value for scholarship will Rs. 7500
- Awarded for II and III years in case the student will be able to secure 80%  $\geq$  in every semester.

A (2). **BPL Scholarship**

- Awarded to students demonstrating financial need as assessed through a comprehensive evaluation process.
- Financial documents such as income certificate (income less than 1.5 lakh/yr.), ration card and family circumstances will be considered.
- Awarded only at the time of admission.
- The value for scholarship will be Rs. 5000.

A (3). **Student Reference Scholarship**

- Awarded to students referring new students to PCTM
- The value for scholarship will be 20% of the tuition fee after the admission confirmation of the new student (submission of the semester fee), and will be applicable on the next semester fee.
- Awarded only once.

A (4). **Faculty Reference Scholarship (FRS)**

- In case Faculty/Staff member refers any new student, the new student will be eligible for FRS which will be 15% of the 1<sup>st</sup> semester tuition fee.
- Awarded only once- for the first semester.

A (5). **Defense Scholarship ARMY/NAVY/AIRFORCE/ BSF/CRPF/ITBP etc.**

- In case the parent of the new student belongs to the above-mentioned category; the student will be eligible for a scholarship of 15% of the 1<sup>st</sup> semester tuition fee.
- Awarded only once- for the first semester.
- In case the parents are deceased the student will be eligible for an additional scholarship of 10% of the tuition fee for the remaining semesters.

A (6). **Sports Scholarship**

- In case the enrolling student is a National / State level player with a valid certificate (valid only for one year) then the student will be eligible for the above-mentioned scholarship.
- The value for scholarship will be 15% of the tuition fee after the admission confirmation of the new student (submission of the semester fee)
- Awarded only once- for the first semester.
- In case the student will participate in any National / State level sport in 1<sup>st</sup> & 2<sup>nd</sup> year, will be eligible for SS for next year.

## “Category B”

### B (1). **Early Bird Scholarship**

- First 50 students completing the registration in April will be eligible for a registration fee waiver and will submit Rs.10000 as part of the semester tuition fee. In case of withdrawal the registration fee Rs. 2000 will be deducted, remaining Rs.8000 will be refunded as per the refund policy.

### B (2). **Women Empowerment Scholarship**

- Female student enrolling for new course will be eligible for a scholarship of 10% of the semester tuition fee.
- Awarded only once- for the first semester.

\* All the above-mentioned scholarships are applicable for KU programs only.

\* Only one sub-scholarship from Category A and only one sub-scholarship from category B is applicable at a time. However, Category A and Category B can be clubbed.

\* For student enrolling for the UOU courses and eligible for any of the above category they will be entitled for Rs.5000 only (one time only)
